From Thursday 11 July 2024, a permit system is in place for residents to apply to dispose of household goods damaged during the floods without charge.

The permit system is **only applicable to flood damaged household contents and goods**, and you must bring the waste to the landfill. (There are NO further kerbside pickups).

This form will also help us to estimate the volume of the waste that will require disposal at landfill.
